

35 MIDDLE STREET BRANCH IN PORTLAND IS OPEN!

We are excited to announce that our new branch location, located at 35 Middle Street in Portland's Old Port, is now open for business! This is cPort's fifth branch. cPort is now Portland's most accessible credit union with three locations.

cPort was founded in 1931 as the Federal Employees Credit Union of Maine at the former Post Office and Courthouse at 169 Middle Street, where Tommy's Park is today. Our return to the corner of Middle Street and India Street allows cPort to better serve the growing number of our current members who live or work on the Portland Peninsula.

The design of the four-story building is in line with the neighborhood's historic district. India Street (previously King Street) is Portland's first street, and the building's Royal River Series brick exterior has "old world charm" and represents the style that would have been used at the time the surrounding historic buildings were built. The exterior metal panels underscore cPort Credit Union's contemporary image and forward thinking. The expanse of glass throughout the first and second floor also allows cPort Credit Union to be visible to the community.

We look forward to serving existing and new members in this new location!

CHANGE TO COURTESY PAY FEE STRUCTURE

Effective on January 2nd, we've changed how Courtesy Pay is charged. You'll now be charged a fee only when a withdrawal of more than \$5.00 creates a negative account balance of more than \$5.00.

- If you make a transaction resulting in a negative balance of \$5 or less, you will no longer incur a fee (regardless of transaction size)
- If you make a transaction of \$5.00 or less while you have a negative balance, you will no longer incur a fee
- If you make a transaction that results in a negative balance change of more than \$5.00 you will now incur a \$27 fee

We noticed that some members were incurring fees on small transactions (\$5.00 or below), so we wanted to improve upon that experience by creating a transaction amount threshold for when the fees would be incurred, thereby reducing the number of times members incur these fees.

Additionally, our Courtesy Pay threshold will increase from \$750 to \$1,000. This means that Courtesy Pay will allow members to withdraw up to \$1,000 before declining transactions.

MEMBER SPOTLIGHT: REUNITING THE LEMBA FAMILY



Clovis Lemba stopped by Forest Ave. branch Member Service Representative Carl Dentici's office to say hi on a recent Thursday afternoon. He introduced Carl to his wife and six year old daughter, who had arrived in Maine the previous Monday. Before Monday, Clovis had not seen his family for five years.

"You can't imagine how happy I am – the emotion after being separated

from my family," said Clovis. Clovis was able to reunite with his wife Grace and daughter Jeannette with the help of a Citizenship Loan from cPort.

Clovis moved to Portland from his home in the Democratic Republic of Congo five years ago. He opened his account at cPort in 2016, and applied for a Citizenship Loan in April to bring his wife and six year old daughter to Portland.

"Carl is awesome," said Clovis about his loan application experience. "I appreciate his professionalism, diligence, and advocacy." Carl explained that Clovis has a strong employment history and good payment history on his car loan, so he was able to secure a next-day approval for Clovis' Citizenship Loan. Clovis used the loan to help pay for classes and rent at a safe place to live for his wife and daughter while preparing to move to Portland. He then used the loan funds to buy their plane tickets once they secured visas and were ready to travel.

Clovis was a doctor back home in the Congo. He plans to continue studying to become fluent in English so he can take his certification exams in Maine and practice medicine here. Grace's background is in computer science and worked at their family pharmacy in the Congo. Jeannette will soon be starting school in Portland. We look forward to helping Grace and Jeannette get started with accounts here in Maine when they're ready – and to seeing the whole family together when they visit our branches!

IRA CONTRIBUTIONS

For 2019, your total contributions to all of your traditional and Roth IRAs may not exceed:

- \$6,000 (\$7,000 if you're age 50 or older), or
- Your taxable compensation for the year, if your compensation was less than this dollar limit.

The deadline for 2018 contributions is April 15^{th} , 2019.

HSA CONTRIBUTIONS

For 2019, your total contributions to your HSA account may not exceed:

 \$3,500 for yourself, or \$7,000 for family. (\$4,500 for yourself or \$8,000 for family if you're age 55 or older)

The deadline for 2018 contributions is April 15^{th} , 2019.

SECURITY TIP: WATCH OUT FOR "APPLE CARE" VISHING ATTACKS

Vishing scams are on the rise. Be aware of the common signs of a vishing attack to avoid becoming a victim. The latest attack goes like this: You receive a call from "Apple Care" claiming your iCloud information has been part of a data breach. The scammer asks you to log in to your computer, so they can establish a remote connection with you and determine the cause of the issue. If you follow their instructions, you'll be allowing the phony "Apple Care" representative to take over your computer, where they can download malicious files or access any personal or private information they'd like to.

To avoid falling for vishing scams, remember these tips:

- If you receive a call from a company that is urging you to complete a request and warns you that something bad will happen if you don't follow their instructions, hang up immediately and call the company directly to investigate.
- Whenever you need to call a company, make sure you are calling the correct and official number, and not a phony "customer service" line that was set up to trick you or steal your information.
- Vishers can spoof any phone number they'd like to. That means that even if a call looks like it is coming from a familiar or safe source, it could be a scam.

Never let an unauthorized person who called you to remote into your computer. If you have any questions about the safety of your account information, please feel free to call us at 1-800-464-0253. We're here to help!
